Entry Policies:

Take-in or exchange dates and times are listed on exhibit schedule, found on the Morro Bay Art Association (hereafter referred to as MBAA), website. Please refer to a more comprehensive MBAA hanging policy online at www.artcentermorrobay.org. All unsold art must be dropped off and/or picked up on scheduled "Exchange" day and time. Failure to pick up unsold artwork on the next scheduled, exchange day, will result in a penalty of \$5.00 per day, up to 30 days. Art not picked up within 30 days will be considered abandoned. All juried entries must remain in the gallery for the duration of exhibit, regardless if sold. Sold entries of a non-juried exhibit, may be removed upon sale, and artists will be asked to replace it with another piece, similar in size, at no additional fee. Replacement information for any item sold must be added to the back of current entry form.

Six (6) months must elapse before any wall-hung piece may be entered again. 3D art may be re-entered into the following show with paid fees and must be rotated out after 2 exhibit periods.
