## Juror: Dennis Curry

Dennis Curry served in the United States Army, 25th Infantry Division's Combat Artists program in 1966 where he documented combat experiences from an artist's perspective.

Upon returning to the U.S., Dennis attended Santa Monica College where he learned original printmaking. He traveled to East Africa and co-founded Duma Safaris with a friend and publisher, Christopher Law. This life changing experience afforded him the pleasure of introducing others to the great game areas that forever influenced his love of nature.

Following an introduction to the contemporary printmaking of Mylar Lithography, he founded Blue Berry Press, located in Cambria, CA., later becoming known for his work in the traditional, intaglio mediums of etching and engraving. Later, moving away from printmaking and wildlife, Dennis began working in the more traditional medium of oil painting to capture the light and color of the landscapes on location and in the studio.

Dennis has significantly contributed to conservation work around the world and his graphics are widely collected nationally and internationally.

Dennis relayed, *"While much art of the past has dealt with the glories and follies of humankind, I feel a need to portray nature for its own sake with the hope of promoting value and respect for our unique planet and the varied form of life with which we share it."*

Dennis is a current member of Society of Animal Artists, Artists for Conservation and San Luis Outdoor Painters for the Environment.

### Awards:

Six paintings will be chosen for awards with cash prizes.

### Artists' Eligibility:

This exhibition is open to all artists who meet the artwork eligibility requirements, as described below.

### Artwork Eligibility:

- We will be accepting 2D only. Oil, watercolor, acrylic, pastel and mixed media in wall hung art.
- Up to five (5) artworks may be submitted per artist. All artworks submitted must be originally conceived by the artist and copyright retained. No direct copies of stock images, historic photos, or of any reference to which you do not hold total copyright are allowed.
- All painting mediums and most 3D artworks are eligible. No computer-generated art, giclée prints, photographs or jewelry will be considered for acceptance. Work must have been completed during the last three years and not previously shown in a Morro Bay Art Center exhibit.
- The artist retains copyright to his/her image(s). Accepted images do become part of MBAA archives and may be used for future MBAA event promotions.

**Digital Submissions:**

All entries will be selected from digital images submitted as email attachments:

- It is to the artist's advantage to submit high-quality images.
- Image(s) must be cropped to show only the photograph, without matting, background or frame.
- Image must represent the artwork to be exhibited exactly.
- File format must be JPG, at least 300 dpi but not to exceed 8MB.
- Each photo file name should include Title, Framed dimensions, & Media. Ex: "BAYSIDE", 30" X 40", acrylic.

- Entry form, digital image(s) and entry fee must be received by August 1, 2019, 5:00 pm.

**Entry Fees and Instructions:**

- Entry fee for current MBAA members and students with student-id: \$15 for one painting, \$10 for each additional entry.
- Entry fee for non-members: \$20 for one painting, \$15 for each additional entry.
- Those wishing to join MBAA may add \$30 annual dues with their entry fee. Membership forms can be found on our website, <https://artcentermorrobay.org/> and in our Art Center Gallery.
- Fees must be paid by check or money order, payable to Morro Bay Art Association, or MBAA. No cash please. Entry fee is non-refundable.

**Method of Selection:**

The juror will make all accepted selections from digital images. Artists will be notified by email of the juror's choice, and chosen entries must then be submitted for the exhibition. Final juror selection will be made from the actual submitted work with the juror's right of refusal.

**Presentation:**

Framing guidelines must be followed:

- Work must be complete, dry, and ready for display.
- Watercolor, egg tempera, batik, charcoal, pastel and colored pencil on *paper* must be framed under glass. Shallow canvas (non-museum-wrapped), all boards and panels must be framed and appropriately wired.
- When framing deep-edged canvas (museum-wrapped canvas or deep board), allow adequate depth so that the substrate does not extend more than 1/2" beyond the back of the frame. One flat surface only, no diptychs or triptychs.
- Flat substrates, including canvas board, gesso board, gesso Masonite, acrylic Gessoed Dibond aluminum, aluminum composite panel and wood are acceptable.
- Hardware: Accepted work must be securely wired and ready to hang using D-rings attached 1/3 down from top. Wire ends must be wrapped for safety of handling.
- No saw-tooth hangers are allowed.

**Delivery of Artwork:**Hand-delivery of Artwork:

Delivery date / times are: Tuesday, September 17, 10 am – 2 pm.

Please submit a one page Artist's Statement for the exhibit binder.

Shipping of Accepted Artwork:

Detailed shipping instructions will be sent when work is accepted. Arrangements for shipping **both to and from** the Art Center Gallery are solely the responsibility of the artist and must be prepaid. No CODs.

A \$25 storage and handling fee will be charged for each package or crate. Please make your check payable to MBAA and place it inside the package, with the return shipping, pre-paid paperwork.

**Sales:**

All work must be for sale. A 25% commission will be retained by the Morro Bay Art Association. Please price your work accordingly.

There will be no price changes after acceptance. MBAA will process all sales, including sales tax. Payment to artist for artwork sold will be made within 7 days from date of sale, after proceeds are verified. The names and addresses of buyers will be provided on request of the artist and permission of the buyer.

**Retrieving Artwork:**

Works of art will be available for pickup by either the artist or purchaser after close of the show on Tuesday, October 29 from 10:00 AM until 2:00 PM. If someone else is picking up your work, they need to have written permission from you to do so, and we will require a signed copy.

Failure to pick up on that day will result in a penalty of \$5.00/day, up to 30 days. Art not picked up within 30 days will be considered property of the Morro Bay Art Association.

**Liability and Conditions:**

Utmost care will be taken in the handling of all articles; however, Morro Bay Art Association – Art Center Morro Bay, its Agents or Representatives shall be held harmless for any errors, claims, loss, theft, or damage of any kind while in the gallery or during transport. By submitting artwork, the artist agrees that MBAA is not responsible for loss of or damage to any artwork or framing materials. No work may be withdrawn before the end of the exhibit.
