Information for replaced artwork, must be added to the back of the current form. Quantity of pieces accepted may depend on available space. All art must be delivered on scheduled take-in day. All unsold art must be picked up on scheduled take-out day, Failure to pick up on scheduled dates, may result in a penalty of \$5.00/day, up to 30 days for storage. Art not picked up after 30 days of scheduled take-out date will be considered abandoned. Six (6) months must elapse before the same artwork may be entered again.
